

# *Wickmere with Wolterton Parish Council*

Minutes of the extraordinary meeting held in the Village Hall, Regent Street,  
Wickmere

on Wednesday 29<sup>th</sup> January 2025 at 7.00 pm

## **AGENDA**

1. **APOLOGIES FOR ABSENCE** – were received from Barry Markham, Saul Penfold and John Toye.
2. **DECLARATIONS OF INTEREST** – there were none.
3. **ADJOURNMENT** - None required.
4. **TO REVIEW THE PRECEPT for 2025/26** – An email from NNDC on 24-01-25 (previously circulated) said a full Council meeting on 29-01-25 would discuss charging second home owners a premium of 100% under Section 80 of the 'Levelling Up and Regeneration Act 2023'. If passed, there would be a resulting revision to taxbase figures for 2025/26. Parish councillors were invited to review and revise precept demands by 31<sup>st</sup> January 2025.  
Wickmere has 71 homes with 13 being second homes/holiday homes which would increase taxbase from 54.10 to 57.20.  
Wickmere Council's decision (15-11-24) to demand a precept of £3500 had resulted in a Band D charge of £64.70 ( $3500/54.10 = 64.70$ )  
With a taxbase of 57.20, increasing the precept demand to £3700 results in a Band D charge of £64.69, thus maintaining a similar Band D charge.  
After discussion and a vote, it was agreed by a majority of 4 to 1 that:
  - i) if NNDC's full council does not implement the second homes premium, and the taxbase remains at 54.10, the precept demand will remain at £3500
  - ii) If NNDC approves the implementation of the second homes premium and the taxbase increases to 57.20, council will revise the precept demand to £3700.
